## Working experience

Sun Yanhui graduated from the Law School of Jilin University in 1990 and started to work as a lawyer since 1992. She is now a senior partner of Beijing King & Capital Law Firm. With nearly three decades of experience in legal practice, she has undertaken hundreds of civil and commercial litigation cases, including a large number of difficult and complicated ones. As one of the first to have received the securities lawyer qualifications in the country, she engaged in the recovery and disposal of non-performing assets of several large asset companies such as Huarong Asset Management Company; handled due diligence reviews over companies including Intellectual Property Publishing Co., Ltd. and completed registration for fund companies; worked on compulsory liquidation of the China Electronic Commerce Association initiated by the Ministry of Industry and Information Technology, and undertook the bankruptcy and reorganization of Heilongjiang Huixiong Real Estate Development Co., Ltd. Before she started practicing, she had worked in the Department of Justice of a province, and then worked in the Northeast Office of a Beijing-based central enterprise as legal affairs specialist.
